DETERMINATION 15 of 2017 - DETERMINATION ON SALARY CLASSIFICATION FOR MEMBERS OF VANUATU POLICE FORCE.

This Determination sets out the salary for members of the Vanuatu Police Force whose appointments or promotions are made by the Police Service Commission or the Commissioner of Police. It comprises:

PART 1 - GENERAL

- 1.1 Authority:
- **1.1.1** This Determination is issued in accordance with section 13(1) of the Government Remuneration Tribunal Act 1998 [CAP 250]
- **1.1.2** The Tribunal may issue guidance notes from time to time to assist the Employing bodies in the administration of this Determination.
- 1.2 Application:
- **1.2.1** This Determination applies to a member of the Vanuatu Police Force other than the Commissioner of the Force.
- **1.2.2** No other person should be accorded the salary stated on this Determination other than those persons stated on section 1.2.1 of this Determination.
- 1.3 Effective Date:
- **1.3.1** This Determination shall take effect on and from 1st January 2018.
- **1.3.2** As and when this Determination takes effect, it shall supersede and revoke any earlier determination and decision made on the salary of members of the Vanuatu Police Force.

PART 2 – SALARY CLASSIFICATION FOR MEMBERS OF THE VANUATU POLICE FORCE

- 2.1 A member of the Vanuatu Police Force who holds an office specified on Table 1 shall be paid the annual salary as is specified for that office on that table.
- **2.2** Adjustment to Salary: Subject to section 2.1 of this Determination, adjustment to salary shall be made in accordance with established performance guidelines and within the ability of the Police Service Commission or the Vanuatu Police Force to pay for the office.

PART 3 - RELATED MATTERS

- 3.1 Take home pay entitlements: On and from 1st January 2018, the Offices listed on Table 1 of this Determination shall no longer be paid the following Take home pay entitlements: Child, Family or Spouse allowance, Cost of Living allowance, Entertainment allowance, Fuel allowance, Housing allowance, and Telephone allowance.
- **3.2 Job Related Allowances:** On and from 1st January 2018, the Offices listed on Table 1 of this Determination shall no longer be paid the following Job related allowances: Detective allowance, Drivers allowance, Instructors allowance, Miscellaneous allowance, Musicians allowance, Plain clothes allowance, Prosecutors allowance, Sergeant Major allowance, Tradesmen's allowance, and Traffic Examiners allowance.

- A Non Commissioned member of the Force with a qualification equivalent to or higher than Vanuatu Qualification Framework (VQF) Level 6 should be paid an annual salary of no less than Grade NCO 7.1 - Vt. 1,386,800.
- A Non Commissioned member of the Force with a qualification equivalent to Vanuatu Qualification Framework (VQF) Level 5 should be paid an annual salary of no less than Grade NCO 6.1 - Vt. 1,195,500.
- A member of the Force appointed as a State Prosecutor should be paid an annual salary of no less than Grade NCO 6.1 - Vt. 1,195,500.
