JUDICIAL SERVICE COMMISSION AND PUBLIC LAWYERS

GRT DETERMINATION ON HOUSING ALLOWANCE, CHILD ALLOWANCE, ELECTRICITY ALLOWANCE, GAS ALLOWANCE, WATER ALLOWANCE, FUEL ALLOWANCE, AND TELEPHONE ALLOWANCE

This Determination applies to positions of: (i) a Judge or Magistrate of the Judicial Service, (ii) a Court Personnel of the Judicial service, (iii) any officer of the Judicial Service, (vi) the Attorney General, (v) a Legal officer in the office of the Attorney General, (vi) the Public Prosecutor, (vii) a Prosecutor in the office of the Public Prosecutor, (viii) the Public Solicitor, (ix) a Legal officer assisting the Public Solicitor, and (x) a support staff in the office of the Attorney General, or a Support staff in the office of the Public Prosecutor or a Support staff in the office of the Public Solicitor, pursuant to subsection 13(1) of the Government Renumeration Tribunal Act No.20 of 1998 [CAP 250]. PART 1. GENERAL

1.1 Authority

- 1.1.1 This Determination is issued pursuant to subsection 13(1) of the Government Remuneration Tribunal Act No. 20 of 1998 [CAP 250].
- 1.1.2 The Tribunal may issue guidance notes from time to time to assist employing bodies with the administration of this Determination pursuant to subsection 24 of the Government Remuneration Tribunal Act No. 20 of 1998 [CAP 250].

1.2 Application

1.1.3 This Determination applies to (i) a Judge or Magistrate of the Judicial Service, (ii) a Court Personnel of the Judicial service, (iii) any officer of the Judicial Service, (vi) the Attorney General, (v) a Legal officer in the office of the Attorney General, (vi) the Public Prosecutor, (vii) a Prosecutor, (viii) the Public Solicitor, (ix) a Legal officer assisting the Public Solicitor, and (x) a support staff in the office of the Attorney General, or a Support staff in the office of the Public Prosecutor or a Support staff in the office of the Public Solicitor.

PART 2. ALLOWANCES AND RELATED MATTERS

- 2.1 The Employing bodies may pay the following allowances presented in the tables, but shall not be more than the ceiling or maximum amount payable, to the employees of the positions specified in PART 1.2.
- 2.2 The officers mentioned In Part 1.2 of this Determination shall be entitled to the following.

3.2 This Determination shall apply to, a clerk of the Island Courts, an officer of the Financial Services Unit, and any officer appointed as a legal practitioner for, or any officer appointed to assist in the general administration or support service of, the office of the Attorney General, the office of the Public Prosecutor, or the office of the Public Solicitor.

PART 3. EFFECTIVE DATE

This Determination takes effect as of 1st December 2024.

The Determination supersedes and revokes any determination or decision relating to allowances stated in Part 2 of this determination for officers mentioned on this Determination.
